in january 1975 president gerald ford signed into law hr 17045 of the health and human services which gave birth to the child support enforcement program this is a federal state program whose purpose was to help strengthen families by securing financial support for children from their noncustodial parents as a bonus this new child support enforcement program along with president johnson s unconditional war on poverty in the america act better known as the economic opportunity act of 1964 was sold to be the answer to eliminate intergenerational poverty cycles here in the united states at the time of this groundbreaking new hr 17045 law the child poverty rate was at 12 percent however standing in the way of this bill passing congress was a heavily favored constitutional bedrock law called the privacy act at its foundation was the 1890 brandeis right to privacy
